1. This form must be signed by the proposer and seconder of the nomination. The declaration at the foot of the first page should be read and signed by the nominee confirming his/her willingness to be elected and his/her understanding that if elected and take office he/she shall assume legal responsibilities as a director and as a charity trustee.
2. The nominee, proposer and seconder must all hold valid membership cards for the 2020-2021 membership year.
3. In terms of the provisions of the Companies Act 2006, the records to be maintained by the Society, as a limited company, will include both the home address of members of the Board of Trustees (as the directors) and their 'service address' for the service of any formal notices. If a director does not wish their home address to be disclosed to the public, they may choose a separate service address. The practice currently adopted by all the directors has been to choose the registered office of the Society at 17 North Street, Bo'ness as their service address.
